TRAINING CONFERENCE

April 18 - 20, 2012

The Fifteenth annual IDEOA training conference is only a short time away and the IDEOA staff is hard at work making the necessary arrangements for a tremendous training forum! The tentative conference agenda is listed on back.

Our main speaker on Wednesday afternoon will be Chief Bob Paudert of West Memphis Police Department. He will speak about the safety threat to law enforcement by the Sovereign Citizens Movement. In May, 2010, his son and another officer were brutally murdered in West Memphis, Arkansas by home-grown terrorists.

Breakout sessions will be three-hour blocks of instruction that run simultaneously. Several breakout sessions are planned, and each officer will be able to attend the sessions they choose. Breakout sessions include:

The cost to attend the IDEOA Training Conference is only \$240.00 for preregistered attendees. Please note: Anyone who has paid in full or has mailed or faxed a department purchase order, with the appropriate registration form(s) by February 28, 2012, is considered preregistered.
