# CONFERENCE INFORMATION

## MARCH 20-22, 2019

The 22nd Annual IDEOA Training Conference is only a short time away, and the IDEOA staff is hard at work making the arrangements for another tremendous training forum! This year's Conference will once again be held at the Embassy Suites Hotel and Conference Center in East Peoria.

Following the Opening Ceremony on Wednesday, our Main Presentation will be *Cartel Operations: A View from Within*.

Thursday Afternoon's Main Session, *Under Fire* will be presented by Lt. Nate Hutchinson of the Weber County (Utah) Sheriff's Office. Lt. Hutchinson was involved in a gun battle after his narcotics team was ambushed while serving a knock and announce search warrant. He will provide a debrief of the search warrant, a detailed account of the gunfight, lessons learned as well as the mindset that helped him survive.

Several breakout sessions are being planned for Thursday and Friday mornings. Sessions will be three-hour blocks of instruction running simultaneously - officers can attend the sessions of their choice. Tentative breakout sessions include:

After a full day of training, IDEOA will lighten the load a bit by hosting networking receptions on Wednesday and Thursday evenings.

The cost to attend the IDEOA Training Conference is only \$275.00 for pre-registered attendees.
